**AUTHORIZING EXPENDITURE FOR OUTSIDE COUNSEL FOR CITIZEN REVIEW BOARD  
PROPOSAL FOR THE VILLAGE OF YELLOW SPRINGS, OHIO**

WHEREAS, a request has been made to engage outside counsel for the purpose of conducting a legal review of the Citizen Review Board Proposal collaboratively prepared, and subsequently approved by the 365 Project in June, 2021; and,

WHEREAS, Village Council has the authority to hire outside legal counsel when necessary,

**NOW, THEREFORE, COUNCIL FOR THE VILLAGE OF YELLOW SPRINGS, OHIO  
HEREBY RESOLVES THAT:**

**Section 1.** Village Council hereby authorizes retention of Attorney James Waddy, Jr. as outside counsel to provide guidance to the Village regarding the establishment of a Citizen Review Board consistent with labor laws, the Ohio Revised Code and the Village Charter.

**Section 2.** The Village Manager is authorized to enter into all necessary agreements to retain outside legal counsel to be compensated upon the submission of bills in an amount not to exceed five thousand dollars (\$5,000.00).

**Section 3.** Attorney Waddy will provide legal review services as described or in a manner substantially similar to those described in the attached Scope of Work, Exhibit A.

Waddy, Jr. and the Village of Yellow Springs (“Village”) dated [REDACTED], 2022, as provided in Section [REDACTED] of that Agreement: specifically, legal review of the Citizen Review Board proposal (the “Proposal”) which was developed and drafted by the Citizen Review Board subcommittee.
