

**VILLAGE OF YELLOW SPRINGS, OHIO
ORDINANCE 2022-37**

**REPEALING OLD SECTION 1060.05 SERVICE CHARGES OF CHAPTER 1060
STORAGE AND COLLECTION OF GARBAGE AND OTHER WASTES OF TITLE SIX
OTHER PUBLIC SERVICES OF PART TEN STREETS, UTILITIES AND PUBLIC
SERVICES OF THE CODIFIED ORDINANCES OF THE VILLAGE OF YELLOW
SPRINGS, OHIO AND ENACTING A NEW SECTION 1060.05 SERVICE CHARGES
AND DECLARING AN EMERGENCY**

Whereas, the Village wishes to enter into a new contract with Rumpke Waste, Inc. for solid waste rates and yard waste collection; and

Whereas, current charges set forth by the Codified Ordinances will fail to meet the financial obligations of increased charges by Rumpke and the cost associated with providing said service; and

Whereas, it is Village Council's intent to amend Section 1060.05 of the Codified Ordinances to meet the aforementioned financial obligations,

**NOW, THEREFORE, COUNCIL FOR THE VILLAGE OF YELLOW SPRINGS, OHIO
HEREBY ORDAINS THAT:**

Section 1. Section 1060.05 *Service Charges* of Chapter 1060 *Storage and Collection of Garbage and Other Wastes* of Title Six *Other Public Services* of Part Ten *Streets, Utilities and Public Services* of the Codified Ordinances of the Village of Yellow Springs, Ohio be repealed.

Section 2. A new section 1060.05 *Service Charges* of Chapter 1060 *Storage and Collection of Garbage and Other Wastes* of Title Six *Other Public Services* of Part Ten *Streets, Utilities and Public Services* of the Codified Ordinances of the Village of Yellow Springs, Ohio be enacted to read as follows with new language in **bold** and text to be deleted in ~~strikeout~~:

Section 1060.05 SERVICE CHARGES

(a) Charges.

(1) The base charges for the collection and disposal of garbage, refuse and/or recyclables shall be in accordance with the following monthly rate schedule. (Note: the reference to quantities below are exclusive of bulk items from residential premises and of the volume of recyclables from recycling bins provided to all customers).

A. Monthly charge per volume of garbage collected weekly – residential service:

C. Recycling: All rates quoted above under residential service include weekly curbside recycling collection. Each resident will be provided with one 65-gallon recycling wastewheeler to hold their commingled recyclables.

D. For the purpose of excess containers of garbage or refuse, the Village Manager is authorized to provide additional stickers for containers or bags, available at the Village Utilities Office. Cost for said stickers shall be:

September 1, 2020 – August 31, 2021	\$1.65/sticker
September 1, 2021 – August 31, 2022	\$1.70/sticker

E. Yard waste shall be collected on the last Friday of every month, April to November. Yard waste must be in a Rumpke-provided bag. The Village Manager is authorized to provide such bags to the public. Bags shall be made available at the Village Utilities Office. Cost for said bags shall be:

September 1, 2020 – August 31, 2021	\$2.78/bag
September 1, 2021 – August 31, 2022	\$2.86/bag

F. The fuel surcharge will be adjusted on a monthly basis based on the Department of Energy's Energy Information Administration (DOE/EIA) highway diesel price index reading for the Midwest region on the last Monday of the month. A fuel surcharge will be added to the monthly rates in accordance with that information.

(2) All surcharges incurred by the Village for the disposal of vehicle tires, appliances containing chlorofluorocarbon, etc., shall be billed at cost.

(3) One-time collections and special services (e.g., large volume users, multiple collections per week, off-street commercial collections, etc.) shall be billed at the costs incurred by the Village plus a 10% processing fee.

(4) ~~The Village shall provide an annual clean-up to customers of the Village Solid Waste Service. The Village Manager shall establish rules and the time of the clean-up. The cost of the service shall be an additional fee, set annually by Council, per account, to be billed separately on the bill or a notice. Cost shall be \$201/ton, plus fuel surcharges for the period September 1, 2020 August 31, 2022.~~ The Village shall provide an annual clean-up to residential customers of the Village Solid Waste Service. The Village Manager shall establish rules and the time of the clean-up. The cost of the service is included in the residential services charges-fee.

(b) Payment. The service charges of this section shall be due and payable on or before the fifteenth day of the month in which bills are rendered. A delayed payment charge of 5% shall be added to any bill paid after the due date. Delinquent accounts shall be certified from time to time to the County Auditor by the Village Manager or his or her designee for collection as other Village property taxes pursuant to Ohio R.C. 735.29.

Section 3. This ordinance is hereby declared to be an emergency measure immediately necessary to preserve the public interest and for the health, safety and welfare of the citizens of the Village, wherefore, this ordinance shall be in effect immediately upon its adoption by Council.
