Whereas, Codified Ordinance Section 1248.02 of the Village of Yellow Springs, Ohio provides the uses in the residential zoning districts; and

Whereas, Village Council has determined that it would be in the best interest of the Village to adopt a new Section 1248.02 entitled "Schedule of Uses" of the Codified Ordinances of the Village of Yellow Springs, Ohio to change transient guest lodging from permitted use to conditional use.

## NOW, THEREFORE, COUNCIL FOR THE VILLAGE OF YELLOW SPRINGS, OHIO HEREBY ORDAINS THAT:

**Section 1.** Section 1248.02 entitled "Schedule of Uses" of the Codified Ordinances of the Village of Yellow Springs, Ohio be repealed.

**Section 2.** A new Section 1248.02 entitled "Schedule of Uses" of the Codified Ordinances of the Village of Yellow Springs, Ohio be enacted to read as set forth on Exhibit A with new language <u>underlined</u> and **bolded** and deleted language in <u>strikethrough</u>, which is attached hereto and incorporated herein.

**Section 3**. This ordinance shall take effect and be in full force at the earliest date permitted by law.

#### **EXHIBIT A**

#### 1248.02 SCHEDULE OF USES.

Buildings or land shall not be used and buildings shall not be erected, except for the following specified uses, unless otherwise provided for in this code. Land and/or buildings in the districts indicated at the top of <u>Table 1248.02</u> may be used for the purposes denoted by the following abbreviations:

- (a) Permitted Use (P). Land and/or buildings in this district may be used by right.
- (b) <u>Conditional Use (C)</u>. Land and/or buildings in this district may be permitted only if conditional use approval is granted, upon a finding that the general requirements of <u>Chapter 1262</u> are met.
- (c) <u>Specific Conditions</u>. Indicates requirements or conditions, as listed in <u>Chapter 1262</u>, are applicable to specific uses.
