ORDINANCE 2019-43

REPEALING SECTIONS 674.04 “ASSESSMENT OF COSTS BY THE VILLAGE” OF THE CODIFIED ORDINANCES OF THE VILLAGE OF YELLOW SPRINGS, OHIO

WHEREAS, Section 674.04 of the Codified Ordinances of the Village of Yellow Springs, Ohio provides the requirements for the Village to trim or cut any noxious weeds not removed by the owner; and

WHEREAS, Section 674.04 of the Codified Ordinances of the Village of Yellow Springs, Ohio provides the requirements for assessing the costs of removing said noxious weeds or grasses to the property; and

WHEREAS, Village Council has determined it would be in the best interest of the Village to no longer trim or cut any trees, weeds or grasses not on Village owned property; and

WHEREAS, Village Council has determined that it would be in the best interest of the Village to repeal section 674.04 “Assessment of Costs by the Village”

NOW, THEREFORE, COUNCIL FOR THE VILLAGE OF YELLOW SPRINGS, OHIO, HEREBY ORDAINS THAT:

Section 1. Section 674.04 entitled “Assessment of Costs by the Village” of the Codified Ordinances of the Village of Yellow Springs, Ohio be repealed.

Section 2. This ordinance shall take effect and be in full force at the earliest date permitted by law.

~~674.04 ASSESSMENT OF COSTS BY VILLAGE.~~

~~—Whenever any tree, plant or shrubbery, or any part thereof, or weeds and grass, are growing in any street, or upon private property contiguous to a street, sidewalk or public place, and are trimmed or removed by the Village, then, after the work is done, the Village shall give five days notice, by regular mail, to the owner of such lot or parcel of land at his or her last known address, or best obtainable address, to pay the cost of such trimming or removal of trees, plants, shrubbery, grass or weeds, or any part thereof. Such notice shall be accompanied by a statement of the amount of cost incurred, and, in the event the same is not paid within thirty days after the mailing of the notice, then such amount shall be certified to the County Auditor for collection of the same as other taxes and assessments are collected. Such remedy shall be in addition to the penalties provided in Sections [674.01](#)(b) and [674.02](#)(c).~~
