- 3) THE DELIVERED READ IS CALCULATED
  - a. USAGE X .11(CURRENT PER KILOWATT HOUR CHARGE)
  - b. USAGE X CURRENT MONTH POWER COST ADJUSTMENT (AVAILABLE ONLINE AND CHANGES MONTHLY
  - c. USAGE X KILOWATT HOUR TAX FORMULA
    - i. THIS IS APPLIED TO THE ACCOUNT AS A CHARGE
- 4) THE RECEIVED READ IS CALCULATED
  - a. USAGE X .11(PER KILOWATT HOUR CHARGE PAID PER NET METERING ORDINANCE)
  - b. USAGE X CURRENT MONTH POWER COST ADJUSTMENT (AVAILABLE ONLINE AND CHANGES MONTHLY)
    i. THIS IS APPLIED TO THE ACCOUNT AS A CREDIT
- 5) THE APPLICABLE CREDIT IS CARRIED OVER EACH MONTH IF IT IS MORE THAN WHAT THE TOTAL CHARGES ADD UP TO (ELECTRIC+WATER+SEWER+SOLID WASTE)
  - a. CREDIT TO BE ZEROED OUT AFTER THE DEC. BILLING EACH YEAR

  - i. THIS IS APPLIED TO THE ACCOUNT AS A CHARGE
- 6) THE RECEIVED READ IS CALCULATED
  - a. USAGE X .09 (PER KILOWATT HOUR CHARGE PAID TO CUSTOMER PER NEW NET BILLING ORDINANCE)
    - i. THIS IS APPLIED TO THE ACCOUNT AS A CREDIT
- 7) THE APPLICABLE CREDIT IS CARRIED OVER EACH MONTH IF IT IS MORE THAN WHAT THE TOTAL CHARGES ADD UP TO (ELECTRIC)
  - a. CREDIT TO BE ZEROED OUT AFTER THE DEC. BILLING EACH YEAR. CHECKS WILL BE ISSUED BEFORE THE JAN. BILLS ARE SENT

## \*\*ALL ELECTRIC CHARGES WILL BE PUT ON A STAND ALONE ACCOUNT, WATER/SEWER/GARBAGE WILL BE BILLED ON A SEPARATE ACCOUNT, SOLAR CREDITS WILL ONLY BE USED FOR ELECTRIC CHARGES. \*\*
