#### **REPEALING SECTION 1258.01 "DISTRICT USES" OF THE CODIFIED** ORDINANCES OF THE VILLAGE OF YELLOW SPRINGS, OHIO AND ENACTING **NEW SECTION 1258.01 "DISTRICT USES"**

Whereas, Codified Ordinance Section 1258.01 of the Village of Yellow Springs, Ohio summarizes the uses allowed in the respective zoning districts; and

Whereas, Village Council has determined that it would be in the best interest of the Village to adopt a new Section 1258.01 entitled õDistrict Usesö of the Codified Ordinances of the Village of Yellow Springs, Ohio to update the conditional uses permitted in E-I zoning districts to include mobile vending (food trucks),

### NOW, THEREFORE, COUNCIL FOR THE VILLAGE OF YELLOW SPRINGS, OHIO **HEREBY ORDAINS THAT:**

Section 1. Section 1258.01 entitled õDistrict Usesö of the Codified Ordinances of the Village of Yellow Springs, Ohio be repealed in its entirety.

Section 2. A new Section 1258.01 entitled õDistrict Usesö of the Codified Ordinances of the Village of Yellow Springs, Ohio be enacted to read as set forth on Exhibit A with new language underlined and **bolded**, which is attached hereto and incorporated herein.

Section 3. This ordinance shall take effect and be in full force at the earliest date permitted by law.
